Rules on fees

<Purpose>

Article 1

This document prescribes fees required for the CFP Communication Program (hereinafter called "the CFP Program") operated and managed by JEMAI (Japan Environmental Management Association for Industry).

<Fees and fee categories>

Article 2

The following 11 types of fees are prescribed for the CFP Program. (For details, refer to Annex 1.)

- 1. CFP-PCR approval
- 2. CFP verification
- 3. CFP registration and release
- 4. Registration/renewal of licensed reviewers
- 5. Training for licensed reviewer prior to registration
- 6. Training for licensed reviewer prior to renewal of registration
- 7. Training for the CFP Program
- 8. Individual consultation for the CFP Program
- 9. Verification of basic secondary data
- 10. Checking of available secondary data

<Setting and collection of fees>

Article 3

Individual fee shall be collected by the payment date prescribed in each type of fee.

Annex 1: Table of fees for the CFP Program

1. Fees for CFP-PCR approval and for CFP verification (Tax included)

<Fees for CFP verification>

- Whether or not the multiple products applied are within one product group is determined through discussions held for each product by using similar products (check sheets). The discussions will be held based on the preconditions that the multiple products applied are: based on the same design concept; produced with the same basic product constitution of main parts and raw materials, etc., and by the common major processes; and with the same functions.
- CFP verification applicant shall submit the attached document for verifying data, including the evidence that the multiple products applied are regarded as a similar product, and the document describing differences among the products.
- When data verification is conducted at a place specified by the CFP verification applicant, there is a case that JEMAI requests travel fees and a day wage for the CFP verifier separately in accordance with the JEMAI's rules.

- The fees for registration and release are charged by JEMAI, in principle by applying the category described above based on all sales amount(s) for one year of the registered/released CFP product(s) which has been sold by the company to be charged.
- The fee of registration and release includes: handling charges associated with registration, release, and management of information; cost of operating the CFP Program; system development and maintenance costs; public relations costs; management cost of emission factor data; miscellaneous costs (labor cost and paperwork cost); and fee for CFP mark license.
- The initial fee for registration and release is calculated from the first day of the next month of the registration to the end of December in the same year. From the next year and onward, the fee is calculated on a yearly basis, from January to December.
- Definition of "Small and medium-sized business" in the category in the table above is used the term from the Small and Medium-sized Enterprise Basic Act.

^{*} It shall be one data set for the following conditions: when verifying emission factor data of multiple products within the same product group at the same time; and when the emission factor data of the multiple products are generated in a similar method and they are compiled into one report.

^{*} Updating of emission factor data that has passed verification and has been registered may/may not require additional data verification depending on the update frequency. Consult with JEMAI for verification fees.
